Dear Parents and Community Members,

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2024-2025 educational progress for Flex High School – Burton Campus. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024 – 2025 school year, schools were identified based on previous years' performance using definitions and labels as required in Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) is one that had at least one underperforming student subgroup in 2024-2025. An additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2023 – 2024. A comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2023 – 2024. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

In the post-COVID era, we continue to identify students with learning gaps by administering NWEA MAP testing bi-annually and utilizing other state aligned formative measures of academic proficiencies. The data we get from these academic measures is used to drive our instruction and allow us to personalize an educational plan to meet each student's unique academic needs.

State law requires that we also report additional information:

1. Student Assignment: Flex High School, Burton is an alternative charter high school that has open enrollment. Our students come to our school from the greater Flint community. And from around Genesee County.
2. School Improvement: Flex High School, Burton strives to improve student achievement through professional development for the staff, student engagement and parent support in our school. This constant cycle of monitoring and improving our student's learning is defined in our formal Michigan Continuous Improvement Plan (MICIP). Our improvement plan targets not only academic growth targets, but also looks at staff, student and parent surveys to maintain Flex High, Burton as a school of

excellence. All students at Flex High, Burton are given the NWEA MAP assessment in math and reading twice per year along with additional standards aligned formative measures to assess academic levels of proficiency. We use this data to drive the individualized instruction that each student receives. Our goal is to have students demonstrate proficiencies on the NWEA and SAT/MME state tests and produce career and college-ready students with the 21<sup>st</sup> century skills. We are proud to support a child-centered learning environment and an academically rigorous curriculum. We are focused on partnering and preparing students for post-secondary transition in alignment with their college and career goals.

3. Flex High Burton is a specialized school that focuses on drop-out recovery and students that are considering dropping out of school.


